Terms and Conditions

The Taxi Club agrees to accept your booking on the following Terms and Conditions

1. **Bookings** A tentative booking may be held for 14 days, after which time confirmation must be made in writing with our Booking Form, signed terms and conditions form and accompanied with a deposit of 10% or \$100 (whichever is greater).
2. **Confirmation** You must provide the Taxi Club with menu selections and any other service you require the Taxi Club to provide at Your function one week prior to function. Your guaranteed numbers are required 72 hours prior to function. This number will be regarded as the minimum number for charging purposes. The Taxi Club will then provide you with an estimate of the cost of the food and services etc. based on your menu selection. You acknowledge that a small increase in the number of guests may be accommodated by the Taxi Club upon Your request; however, the number of guest cannot be reduced. Naturally, the estimated cost shall be deemed to increase in accordance with any increase in the number of guests and their requirements.
3. **Cancellations** A booking confirmed in accordance with Paragraph 1. Bookings may only be cancelled in writing a minimum of 2 weeks prior to function otherwise the full deposit will be forfeited.
4. **Responsibility** You hereby indemnify The Taxi Club against all losses, damages and claims that the Taxi Club may incur, suffer or pay, as a result of any loss of property during the course of, or after Your function or as a result of any damage sustained to the Venue and / or any properties that belongs or is part of the building whether by your own action or by the actions of Your invited guests. It is your responsibility to advise Your guests of the start/finish time of Your function. You acknowledge that the Taxi Club shall not be responsible for any activities that may take place in such areas during Your function.
